SUBJECT: Adjustment to projects 17-2014-232 (Lenoir City ITS: Signal System Design) and 17-2014-079 (City of Loudon Traffic Flow Improvement Project)

Dear TDOT,

The Knoxville Regional TPO requests concurrence by TDOT to adjust the FY 2017-2020 TIP concerning the following projects:

Adjustment 17-2014-232 (Lenoir City ITS: Signal System Design) - Adjust project by adding 20% state match (\$21,245) for the \$106,224 ADA costs to FY2018 CMAQ. Shift \$84,979 federal FY2017 CMAQ to FY2018 CMAQ to reflect 80% federal share for ADA costs. The total federal CMAQ amount remains unchanged. The total project increases by \$21,245 to \$1,354,745.

Adjustment 17-2014-079 (City of Loudon Traffic Flow Improvement Project) - Adjust project by adding 20% state match (\$41,609) for the \$208,045 ADA costs to FY2018 CMAQ. Shift \$166,436 federal FY2017 CMAQ to FY2018 CMAQ to reflect 80% federal share for ADA costs. Add the TDOT PIN 122610.00. The total federal CMAQ amount remains unchanged. The total project increases by \$41,609 to \$1,385,009.

These adjustments have been incorporated into our FY 2017-2020 TIP. The project pages and expenditure summary sheets are included with this letter. If you have any questions please contact me at (865) 215-3825.






