The Knoxville Regional TPO requests concurrence by TDOT to adjust the FY 2017-2020 TIP concerning the following project:

Adjustment 17-2014-007 (Foothills Mall Drive Extension) - Adjust project to revise the total project cost to \$4,924,000. Prior NEPA cost reduction of \$10,500 was not deobligated from project and remains in the total project cost. \$8,760 of the \$10,500 was needed for NEPA costs, while \$1,740 (\$1,392 federal/\$348 local) from NEPA phase remains available for project costs.

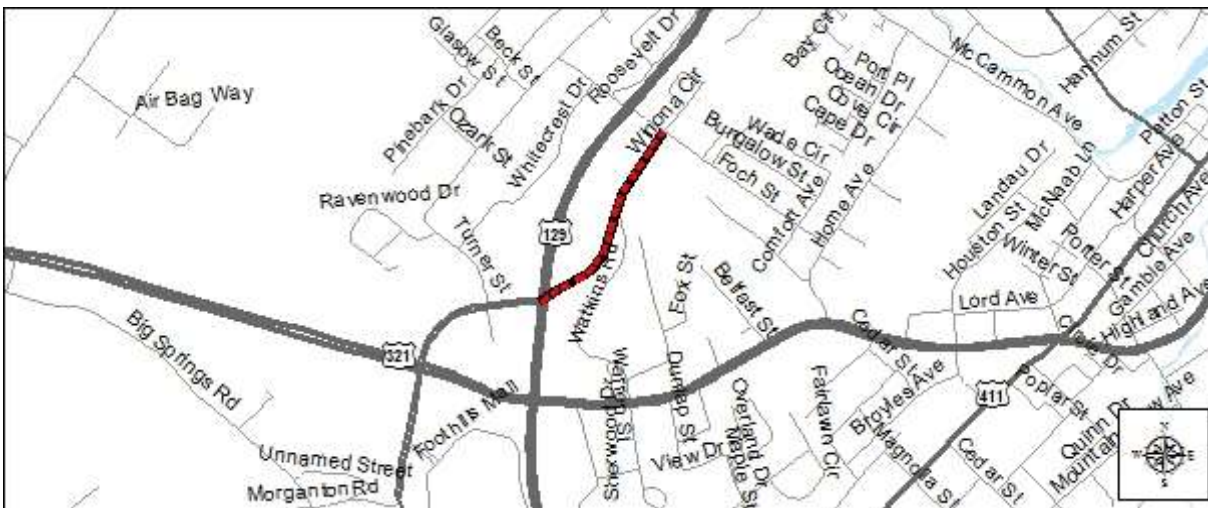

FY 2019 CN is adjusted to reflect the current estimate of \$4,000,000 (\$3,200,000 federal/\$800,000 local). This adjustment adds \$824,000 L-STBG to the TIP, increasing the total project cost to \$4,913,500.
